**Re: Request for Information Related to Voter Registration List Maintenance**

Dear Ms. Dul:

As you are aware, the Senate has completed significant portions of its forensic audit, and has provided reports to the Arizona Attorney General's Office, which are being reviewed by the Elections Integrity Unit ("EIU").

Many of the issues identified in the reports pertain to voter registration list maintenance. As we begin the review, the EIU requests the following information from the Secretary of State's Office ("SOS"):

1. Any and all data files, reports, lists, records, spreadsheets, documents, or logs provided by the United States Postal Service or its licensees ("USPS") to the SOS or its designee as it relates Arizona voter registration file maintenance as prescribed by 52 U.S.C.A. 20507(c)(1) from the period of October 1, 2019 to present.
2. Any and all data files, reports, lists, records, spreadsheets, documents, or logs provided by Arizona superior courts or its designee ("AZSC") to the SOS or its designee as it relates to Arizona voter registration file maintenance as prescribed by A.R.S. § 16-165(C) from the period of October 1, 2019 to present.
3. Any and all data files, reports, lists, records, spreadsheets, documents, or logs provided by United States District Court or its designee ("USDC") to the SOS or its designee as it relates to Arizona voter registration file maintenance as prescribed by A.R.S. § 16-165(C) from the period of October 1, 2019 to present.
4. Any and all data files, reports, lists, records, spreadsheets, documents, or logs provided by Arizona Department of Health Services or its designee ("AZDHS") to the SOS or its designee as it relates to Arizona voter registration file maintenance as prescribed by A.R.S. § 16-165(D) from the period of October 1, 2019 to present.



5. Any and all data files, reports, lists, communications, records, information, spreadsheets, emails, documents, or logs sent between the SOS or its assigns and Arizona counties, including county recorders, county election officials, or county board of supervisors, intended to transmit records or information obtained from USPS, AZSC, USDC, or AZDHS that were provided to counties in order to perform statutory functions defined in A.R.S. § 16-165(C), (D) and 52 U.S.C.A. § 20507(a)(4) from the period of October 1, 2019 to present.

Please promptly provide the materials requested electronically on a rolling basis as it becomes available, and where possible in its original format. This request should be construed liberally to provide any and all communications, documents, data files, reports, and records that pertain to the SOS's statutory duty to provide information to counties and coordinate issues related to maintaining voter registration records. The EIU makes this request pursuant to Arizona Public Records Law, A.R.S. § 39-121 *et seq.* If any documents are withheld, the EIU requests that you furnish an index of records or categories of records that have been withheld and the reasons for withholding. If costs are expected to exceed \$50, please provide advance notification.
